**Indemnification, Hold Harmless, and Insurance:** In consideration for the use of the facilities, you agree that: (a) you will pay for any and all damage to the property of the City of Summit or Reeves-Reed Arboretum, Inc. resulting directly or indirectly from the conduct of any of your members, officers, employees, agents, hired help, contractors, vendors, or other invitees in connection with the use of the facilities; (b) you will hold harmless and indemnify the City of Summit and Reeves-Reed Arboretum, Inc. from and against any and all liability which may be imposed upon either or both of them for any injury to persons or property caused by you or any other person, in connection with the use of the facilities for your event.

**Cancellation:** Permit fees are non-refundable. The permit does not include access to any Arboretum buildings. In case of inclement weather, call 908-273-8787 x 1010 (Tuesday - Friday) to reschedule.

The Arboretum is a living museum. Please exercise care when posing and setting up equipment. Do not walk or stand in flower beds or on plants. Do not climb trees, sculptures or water features. Do not block paths or roadways. Low riding stretch limousines will bottom out at the exit ramp and are prohibited to enter. Wedding parties should be dropped off outside the entrance gate and enter the grounds through the pedestrian gate. **Drones, alcohol, smoking, vaping and pets are NOT ALLOWED** on the Arboretum grounds.

A photography permit does not allow participants access to the Wisner House or any Arboretum buildings. Restrooms are available near the patio off the driveway.

I/We have read and agree to abide and be bound by the terms of this Agreement.

I/We understand that in the event of any breach of this Agreement, including but not limited to a breach of the Arboretum's Photography Regulations, the Arboretum may enter and retake possession of the premises, regardless of whether my/our photo shoot/filming event is in progress.
